Chair's Message

I recently had the privilege of addressing the South Carolina state assembly at their meeting in Beaufort, South Carolina hosted by the Technical College of the Lowcountry. The people who arranged the meeting were clearly a dedicated group of people who wanted to see the profession grow in their state. I was honored to be invited to address the group of attendees. The topic of my presentation was "Professional Involvement." Now that I am home from the annual conference, I feel even more strongly about individual involvement in the surgical technology profession.

The economic situation for each state varies and the opportunities for professional involvement are dependent on money that is available for travel or program development. For many people, the lack of money limits travel. But, there is much more to professional involvement than travel to state assembly meetings or to the national conference.

I strongly believe that the Surgical Technology profession is represented by each surgical technologist who enters an operating room each day. We are the models that patients, surgeons, and students see on a daily basis. We are the ones who define our profession.

So, how do we become involved? For some people, it is the daily presence in the operating room and performing at the highest level that they can. For others, it is in the educational process passing on experience and knowledge to the new techs. And for others still, it is assuming responsibility for the leadership roles of state assemblies or on national boards or committees.

Involvement really begins in the operating room with the patient and the peri-operative team as we perform our duties to the best of our abilities. This is the daily level of involvement that defines us as surgical technologists and professionals. Many of the surgical technologists that precept our students may not have attended a formal training program themselves. They certainly have much to contribute to the profession and to the education process by sharing their wealth of experience. Certification falls into this level as well. The facility where you work may not require certification for employment, but, is that the only reason to be certified? I hope it is not. It would be a great thing if the employer recognized the importance of certification and rewarded it with a pay increase. That may or may not happen and it is not something that should be waited for.

Chair's Message (cont.)

I became certified at a time when my employer did not require it (and still does not) because I wanted it for myself. That was 17 years ago and I have never regretted the decision. Yes, it is an investment of time and money. Once certified, I have to maintain CEU's and renew at the end of each cycle. I knew when I entered the profession 27 years ago that I had entered a life-long learning process. I still want to learn new things and expand my knowledge of new techniques and surgical procedures.

My involvement began when I started precepting new employees to our facility. It was a good feeling to be able to help new people get a start. After ten years at the hospital, I started teaching in the Surgical Technology program at the local community college. I became a site visitor for the ARC-ST and started traveling to other programs to evaluate their compliance with CAAHEP standards. I want every program to teach at a high level. After all, this is my profession too, and I want everyone in the operating room to be able to perform at a competent level.

I teach in a program and pair students with preceptors each clinical day. Some of the techs are eager to teach what they know while others are quick to tell the students that they are not welcome in the room. That is such a wrong message to be sending to people who want to join our profession. Our profession needs to grow so that each patient can have a surgical technologist on the operative team.

If there is a surgical technology program in your region and your facility is used as a clinical site for students, you could volunteer to help the program and students by becoming a preceptor or you could represent your facility as a member of the program's advisory committee. Preceptors are vital to the education process. Surgical Technology programs can only teach so much in the

classroom and the lab settings. The practical application of knowledge is in the operating room performing surgical procedures. Involvement at this level is taking a student under your wing and helping him or her learn in a comfortable environment. Teaching students in the clinical setting could lead to a teaching position at the local program.

Each state has its own assembly and group of people who dedicate their time and money to ensure that each member gets educational opportunities as well as representation. You could become involved at the state level by holding an office or hosting a state meeting. Most of the state assemblies hold meetings on Saturdays throughout the year. One of the greatest needs is a site willing to host the meeting and getting speakers for presentations. This is something that can be beneficial for you as well as the state assembly. You can earn CEU's as well as representing your facility at the state meetings.

The annual conference has its own opportunities as well. Each state sends delegates who vote for legislation and national officers. Again, there are many CEU's available for conference attendees. And, of course, there is the opportunity to seek office on the AST Board of Directors or become a member of a committee. This level takes a lot of time throughout the year. Most conference attendees see all of the opportunities that are available. Most do not realize the amount of time and planning that go into each conference that make them go as smoothly as they do. Yes, there are bumps along the way; a presentation is cancelled, or something does not go as planned. Those things happen at all conferences. But, at the close of conference, the satisfaction of a successful event is evident.

The level of involvement in our profession is only limited by what you are willing to put into it. Each level has its own commitments and time demands. It is up to you to decide what role you want to take to help our profession grow.

NEW PROFESSIONAL DEVELOPMENT REQUIREMENTS FOR 2009 FOR NEWLY APPOINTED SURGICAL TECHNOLOGY AND SURGICAL ASSISTING PROGRAM DIRECTORS

At the Fall 2008 Board of Directors meeting, the board approved a new mandatory professional development requirement for newly appointed program directors.

Effective **January 1, 2009**, all newly appointed program directors are required to attend an ARC/STSA *Accreditation Fundamentals for Educators (AFE)* Workshop within **one (1)** year of appointment.

The AFE Workshop is designed to give program directors, instructors and administrators basic information on the accreditation process, including:

- Accreditation Definitions
- Institutional versus Programmatic Accreditation
- Initial versus Continuing Accreditation
- Terminology Associated with Accreditation
- Accreditation Actions
- The Accreditation Process
- Assessment Planning
- Standards Interpretive Guide (SIG)
- Annual Reporting Requirements
- CAAHEP Standards & Guidelines
- Program Review Report
- Types of Accrediting Bodies
- Findings Letter Responses & Progress Reports

While this workshop is open to all Surgical Technology and Surgical Assisting Program Directors and educators, newly appointed ST and SA program directors will be required to submit proof of attending an AFE to the ARC/STSA in support of their appointment.

The workshops will be offered three times per year:

- before the AST Instructors Forum (Friday, February 5, 2010 in Charleston, SC)
- during the AST Instructors Workshop (Wednesday, May 26, 2010 in Dallas/Ft. Worth, TX)
- on August 7, 2010 in Denver, CO (registration and information available online at www.arcstsa.org)

The cost of the workshop is **\$50 plus travel and accommodations**.

At its Fall 2008 meeting, the ARC-ST Board of Directors, in collaboration with the Subcommittee on Accreditation for Surgical Assisting (SASA), decided to change the name of the ARC-ST to better reflect all education programs served by this organization.

Effective *August 1, 2009*, the ARC-ST officially became the:

Accreditation Review Council on Education in Surgical Technology and Surgical Assisting (ARC/STSA).

As we approach the Holiday season, the ARC/STSA Board of Directors (BoD), its Subcommittee on Accreditation for Surgical Assisting (SASA) and the accreditation services staff wish you and your students Season's Greetings and a Happy New Year.

Since our last newsletter, the Spring/Summer edition of the *Communiqué*, highlighted below is a summary of programmatic accreditation services for surgical technology and surgical assisting programs over the last 6 months due to the work of the SASA, ARC/STSA and CAAHEP. They include:

- Launched new name and logo, the **Accreditation Review Council on Education in Surgical Technology and Surgical Assisting** (ARC/STSA) August 1, 2009.
- Adopted formal **outcomes exam thresholds** for ST programs electing the CST exam as their outcomes assessment tool at **100% participation and 70% pass rate** for completing cohorts/classes **effective August 1, 2009**.
- Established *deadline* of **August 1, 2011** for all ST programs to implement the CST exam as their sole **outcomes assessment exam** for reporting purposes.
- Conducted 25 on-site visits and 160+ reviews of program applications, progress reports, and other accreditation actions from May 2009 through November 2009.
- Recommended 7 Initial and 25 Continuing accreditation awards in surgical technology and surgical assisting with approximately 465 surgical technology and 10 surgical assisting CAAHEP accredited programs to date.
- Renewed the ARC/STSA **Scholarship Program** for 2010 totaling \$3000 in three categories as a service to the student and educator communities (applications and details available at www.arcstsa.org/2010_scholarship.htm).
- Launched a formal "communities in need" outreach effort with a donation of \$1000, and collaborating with the AST and the NBSTSA, to sponsor similar activities annually before each national Conference.
- Welcomed 7 new **on-site evaluators** to the ARC/STSA family of visitors.
- **Mark Shikhman, MD, PhD, CSA** joined the SASA as its newest member. Dr. Shikhman is both the surgical technology and surgical assisting program director at Wayne County Community College, Western Campus, Belleville, MI.
- **Kathy Lee, CST, MS, FAST**, current Vice Chair and BoD member, elected as the new ARC/STSA Commissioner to CAAHEP.

- Enhanced the new **Standards Interpretive Guide (SIG) - Surgical Technology** (www.arcstsa.org/pdfs/SIG-ST.pdf) and developed and launched the new **Standards Interpretive Guide (SIG) - Surgical Assisting** to assist programs in complying with current CAAHEP *Standards & Guidelines*.
- Inaugurated *outcomes assessment* consistent with the published **Implementation Timeline** to assist SA programs in complying with the 2008 CAAHEP Surgical Assisting **Standards & Guidelines** (outcomes assessment effective August 1, 2009.)
- Hosted the enhanced **Accreditation Fundamentals for Educators (AFE)** workshop in August for 30+ participants. *The AFE is a required tool to assist all new program directors (effective January 1, 2009) and is available to all program directors, instructors and school administrators.*
- Contributed to CAAHEP's new **Your Accreditation Mentor**, an online service for program directors to guide understanding of accreditation processes and to share advice on good practices (www.youraccreditationmentor.com/).
- Updated and posted standardized ARC/STSA reporting forms on the website for easy access 24 hours a day (www.arcstsa.org/forms/ST/index.htm).
- Exhibited at the American College of Surgeon's 95th Clinical Congress in Chicago.
- Renamed our semi-annual newsletter, effective with this issue, to the **ARC/STSA Outreach**, to better reflect its purpose and function in serving our communities of interest.

ARC/STSA and CAAHEP share the mission to provide world-class recognition for quality surgical technology and surgical assisting education, through specialized programmatic accreditation services, to the student, educator, regulatory and healthcare consumer communities. CAAHEP accreditation continues to serve as the *gold standard* for programmatic accreditation in the healthcare professions. The ARC/STSA is proud to collaborate with CAAHEP in service to all of our communities of interest.

The ARC/STSA is the sole Committee on Accreditation (CoA) recognized by CAAHEP for accreditation of education programs in surgical technology and surgical assisting, rendering professional services to both allied health disciplines using volunteer evaluators. New site visitor applicants are needed. All qualified candidates are urged to apply (please see the *Site Visitor Information* link at www.arcstsa.org).

Congratulations to all those programs which have been awarded initial and continuing CAAHEP programmatic accreditation...we applaud your continuing commitment to excellence in surgical technology and surgical assisting education through specialized programmatic accreditation.

2008 CAAHEP Standards Implementation

The Commission on Accreditation of Allied Health Education Programs (CAAHEP), upon the recommendation of the Accreditation Review Council on Education in Surgical Technology and Surgical Assisting (ARC/STSA) and its Subcommittee on Accreditation in Surgical Assisting (SASA), adopted the 2008 CAAHEP *Standards & Guidelines for Education in Surgical Assisting* as approved by the *American College of Surgeons (ACS)*, the *Association of Surgical Technologists (AST)* and the *National Surgical Assistant Association (NSAA)* which are now in effect. These revised SA Standards are part of a CAAHEP process which requires each of the Committees on Accreditation (e.g.; SASA—ARC/STSA) to periodically review and update their standards to reflect both outcomes-based accreditation and changes to the educational needs of the profession.

These SA *Standards & Guidelines* are the direct result of three years of review and analysis as part of the CAAHEP process for standards revision and are designed to address the needs of our sponsors, accredited programs, students, practitioners and educators in reflecting the professional development of the field of surgical assisting.

The 2008 SA *Standards & Guidelines* became effective August 1, 2008 and are posted on the ARC/STSA website (www.arcstsa.org) for easy access. Please note, only programs previously accredited or which have submitted a *completed* accreditation application package to the SASA—ARC/STSA prior to August 1, 2008 may continue to operate under the 2002 Standards & Guidelines, but only for a limited time as detailed in the 2008 Standards Implementation Timeline. Those programs should begin to transition to the 2008 Standards and should refer to the **2008 Standards Implementation Timeline** (page 6) to determine which Standards may be met at a later date.

Timeline for Surgical Assisting 2008 Standards Compliance

New Applications: Initial applications received *on or after* August 1, 2008 must comply with all 2008 Standards.

Current Applications: Initial applications received *before* August 1, 2008—see timeline for currently accredited programs below.

Currently Accredited Programs: Accredited programs must meet or exceed all *Standards* on **August 1, 2008** except as follows:

- **Standard I A 1** Institutional Accreditation **August 1, 2010**—Mandatory demonstration of institutional accreditation (national or regional).
- **Standard III C** Resources – Curriculum **August 1, 2010**—Mandatory demonstration of compliance with Core Curriculum for SA, 2nd Ed.
- **Standard IV B** Student Evaluation – Outcomes Assessment—**August 1, 2009**
 - Implement outcomes assessment beginning with academic year 8/1/09 – 7/31/10
 - Core Indicators = Graduate Satisfaction, Employer Satisfaction, retention, placement and program assessment examination (CFA or CSA exam)
 - Program initial annual reporting of outcomes will begin with the 2011 Annual Report

ARC/STSA Accreditation Packet **\$75**
(Effective July 1, 2010 = \$150)
 The ARC/STSA Accreditation Packet (otherwise known as the Self-Study packet) should be ordered when a program is pursuing application for initial accreditation. Materials in this packet include accreditation process and procedure documentation and materials required for submission of the Self-Study application.

Initial Accreditation—Application Fee **\$1200**
(Effective July 1, 2010 = \$1500)
 This fee is due and must be submitted with the submission of the initial Self-Study application.

Initial Accreditation—On-Site Evaluation Fee **\$2500**
 The initial on-site evaluation fee covers preparation and travel expenses to the program's main campus incurred by the ARC/STSA. Due upon submission of the initial Self-Study application.

PRR Continuing Accreditation—Application Fee **n/a**
(Effective July 1, 2010 = \$1000)
 This fee is for all programs seeking transition from Initial to Continuing accreditation. Due upon submission of the Program Review Report application.

Consultative—On-Site Evaluation Fee **\$4000**
 The consultative site visit fee covers preparation and travel expenses incurred by the ARC/STSA. Please refer to the ARC/STSA website for circumstances requiring a consultative on-site evaluation. Due at least 30 days prior to the on-site evaluation.

ARC/STSA Annual Accreditation Fee **\$1500**
 Annual accreditation maintenance fee due for all accredited programs. Programs are invoiced in January annually. (**Please note: CAAHEP invoices a separate accreditation maintenance fee by institution annually).
Note: Fees for Random/Continuing on-site evaluations are included in the ARC/STSA Annual Fee.

Core Curriculum for Surgical Technology or Core Curriculum for Surgical Assisting
 (Published by AST; available at 800-637-7433)
 Standard III.C requires that programs meet or exceed the curricular requirements defined in the program-specific Core Curriculum.

ARC/STSA Approved Program Assessment Exams
 For PAE contact AST at 800-637-7433.
 For CST or CFA contact NBSTSA at 800-707-0057.
 For CSA contact NSAA at 888-633-0479.
 Standard IV.B requires that programs implement one of these approved Outcomes Evaluation Tools, elected by each program, as part of ongoing outcomes accreditation requirements.

Distance Education—Application Fee **\$250**
(Effective July 1, 2010 = \$500)
 For all programs pursuing approval of Distance Education (DE) programs. Due upon submission of DE application.

Satellite and/or Consortium—Application Fee **\$250**
(Effective July 1, 2010 = \$500 per campus)
 For all programs pursuing approval to offer program at multiple facilities through Satellite or under Consortium models. Fee is multiplied per satellite or consortium facility. Due upon submission of Satellite and/or Consortium application.

Satellite—On-Site Evaluation Fee **n/a**
(Effective July 1, 2010 = \$2500 for main campus and \$1500 for each satellite facility/campus)
 The satellite on-site evaluation fee covers preparation and travel expenses incurred by the ARC/STSA. Fee is multiplied by number of satellite facilities/campuses. Due upon submission of Satellite Self-Study application.

AAD Option—Initial Application Fee **\$250**
(Effective July 1, 2010 = \$500)
 For surgical technology programs pursuing approval of an Accelerated Alternate Delivery (AAD) option in tandem with their accredited traditional program. Due upon submission of the AAD application.

AAD Option—Annual Maintenance Fee **\$250**
(Effective July 1, 2010 = \$500)
 Surgical technology programs that have been approved to offer the AAD option will be invoiced an annual fee in addition to the ARC/STSA annual fee.

Distance Education/Satellite/Consortium-Annual Maintenance Fee **\$500**
 All programs approved to be offered at multiple facilities or through a distance education, satellite or consortium model will be invoiced this annual fee per additional facility, in addition to the ARC/STSA annual fee for the main campus.

ARC/STSA Late Fee **\$100**
 The ARC/STSA strictly enforces a late fee which applies to any materials received by the ARC/STSA office after the assigned/requested due date. This fee will only be waived if the program notifies the ARC/STSA prior to the due date of its inability to meet the assigned date and an extension is granted by the ARC/STSA. Only one extension of up to 30 days will be granted to each program.

CAAHEP Annual Accreditation Fee **\$450**
 CAAHEP annual accreditation maintenance fee is separate from any ARC/STSA fees. Each sponsoring institution is directly invoiced by CAAHEP every May.
