SUPPORTING STUDENT SUCCESS IN THE CLINICAL SETTING — One Approach

The clinical phase of the Surgical Technology education process can be one of the most daunting and challenging for the OR novice. It is the first opportunity that students have to experience operating room practice outside of the controlled classroom and laboratory setting. Each clinical facility has their own institutional practices which may differ from those instructed in mock lab. The pace in the OR is faster than in lab, there is a real patient on the bed, and the variables are no longer easy to predict and control, as each patient is unique. One of the responsibilities of the clinical educator is to assist the student in transitioning from the controlled environment of the classroom/lab to "live" operating room. Identifying strategies to assist and support the student during this time of transition is critical to their success.

The Surgical Technology program at Guilford Technical Community College (GTCC) in Jamestown, North Carolina has developed two strategies to support student success in transitioning from class to clinical to professional practice. These approaches were developed in partnership with its clinical affiliate, Moses Cone Health Care System. The GTCC-ST program uses three of the four hospitals in the MCHS system for its clinical rotations.

The first strategy used to promote student success is to identify, utilize and recognize outstanding preceptors. An outstanding preceptor is one who is willing and able to guide, mentor, and collaborate with the students as they practice and perfect their professional knowledge, skills, and behaviors. At the end of each year the students select one preceptor at each clinical site for special recognition

and award them a certificate of appreciation. The students then select a "Preceptor of the Year" from that group of recognized preceptors. The "Preceptor of the Year" is recognized with an additional certificate.

The second strategy used to support student success is to pair an experienced CST with a student during their educational experience. The CST and student are paired by the program director and available CST's and maintain contact by phone, email, or face-to-face meetings during the school year. It is entirely up to the student and preceptor as to the frequency and type of communication. The advantage to the student is to able to ask the CST questions about professional issues or clinical situations that arise from their studies or clinical experiences throughout the year. The advantage to the CST is to learn how the student progresses through the education process. The CST continues to act as a mentor for the student, even if the student is not assigned to their clinical site. The bond that this team establishes often continues even after graduation and if the student is employed at the CST's facility, the CST becomes the orienting tech for the student.

This partnership creates a win/win situation for the team. The student is able to establish contact with a CST who serves as an additional source for information and support during formal education. The CST is able to develop teaching and mentoring skills and can serve as a professional reference for the student as they graduate and enter the workforce.

GTCC has recognized its outstanding preceptors for more than 10 years. The preceptor/student partnership was proposed by the CSTs at the clinical sites. Students, graduates, preceptors, and employers report that these strategies have had a positive impact on GTTC's ability to prepare tomorrow's healthcare workforce.

Executive Director's Corner

I am pleased to report a very active and challenging 2008 for the ARC-ST team including the Board of Directors, the Subcommittee on Accreditation for Surgical Assisting (SASA) and the accreditation services staff.

Positive events affecting programmatic accreditation services for surgical technology and surgical assisting have taken place in the last 12 months as a result of the work of both the SASA, ARC-ST and CAAHEP, some of which are highlighted below.

- ARC-ST conducted 250+ reviews of program applications, progress reports and other accreditation-related activities from September 2007 to September 2008.
- Awarded 2008 **Scholarships** totaling \$3000 to 3 students and 2 educators (see the 2009 Scholarship program announcement in this issue of the *Communiqué*.)
- Philanthropic outreach included donations the American College of Surgeons Project New Orleans post-Katrina emergency relief effort and Project C.U.R.E.
- Van Bates, CST, BA and Dorothy Rothgery, CST/ CFA, MS, joined SASA as its newest members.
- Ann M. McGuiness, CST, MSEd, CNOR, joined the ARC-ST staff as the new ARC-ST Director of Accreditation Services (DAS).
- New CAAHEP Surgical Assisting Standards & Guidelines were developed, presented at open hearing, adopted and implemented effective August 1, 2008.
- New Accreditation Fundamentals for Educators (AFE) workshop launched successfully at the annual Instructor's Forum and the Instructor's Workshop.
- Hosted two Site Visitor Training workshops, Beginning and Advanced, at both the Instructor's Forum and Instructor's Workshop incorporating a new CAAHEP online Site Visitor Training module.
- ARC-ST hosted the biannual Strategic Summit
 meeting including AST and the National Board for
 Surgical Technology and Surgical Assisting
 (NBSTSA) to address issues affecting the practice
 through legislation, education, and credentialing.
- Launched pilot-test of and transition to the national CST examination as an approved *outcomes measurement* for those programs electing to begin doing so August 1, 2008.
- Approved official name change to the Accreditation Review Council on Education in Surgical

Technology and Surgical Assisting (ARC-STSA) effective August 1, 2009.

As our work has grown significantly, the ARC-ST is seeking applications from qualified candidates for a 2009-2012 term appointment to the ARC-ST Board of Directors (Please see the announcement below).

The long association between ARC-ST and CAAHEP has reinforced a mutual commitment to our collaborative mission of providing world-class recognition for quality surgical technology and surgical assisting education, to the student, educator, regulatory and healthcare consumer communities, through specialized programmatic accreditation services. CAAHEP accreditation continues to serve as the *gold standard* for programmatic accreditation in the healthcare professions.

The Subcommittee on Accreditation in Surgical Assisting (SASA) Updates

The Commission on Accreditation of Allied Health Education Programs (CAAHEP), upon the recommendation of the Subcommittee on Surgical Assisting Accreditation (SASA) and the Accreditation review Committee on Education in Surgical Technology (ARC-ST), adopted the 2008 CAAHEP Standards & Guidelines for Education in Surgical Assisting as approved by the American College of Surgeons (ACS), the Association of Surgical Technologists (AST), the National Surgical Assistant Association (NSAA) at the open hearing in Denver on July 25, 2008. These revised SA Standards are part of a CAAHEP process which requires each of the Committees on Accreditation (e.g.; ARC-ST/SASA) to periodically review and update their standards to reflect both outcomes-based accreditation and changes to the educational needs of the profession.

These SA Standards & Guidelines are the direct result of three years of review and analysis as part of the CAAHEP process for standards revision and are designed to address the needs of our sponsors, accredited programs, students, practitioners and educators in reflecting the professional development of the field of surgical assisting.

The SA Standards & Guidelines became effective August 1, 2008 and are posted on the ARC-ST website (www.arcst.org) for easy access. Please note, only programs currently accredited or which have submitted a completed accreditation application package to the SASA/ARC-ST prior to August 1, 2008 may continue to operate under the 2002 Standards & Guidelines for a limited time. Those programs should begin to transition to the 2008 Standards and should refer to the 2008 Standards Implementation Timeline below to determine which Standards may be met at a later date.

Timeline for Surgical Assisting 2008 Standards Compliance

New Applications: Initial applications received on or after August 1, 2008 must comply with all 2008 Standards.

Current Applications: Initial applications received before August 1, 2008—see timeline for currently accredited programs below.

Currently Accredited Programs: Accredited programs must meet or exceed all Standards on August 1, 2008 except as follows:

- Standard I A 1 Institutional Accreditation August 1, 2010 Mandatory demonstration of institutional accreditation (national or regional).
- Standard III C Resources Curriculum August 1, 2010 Mandatory demonstration of compliance with Core Curriculum for SA, 2nd Ed.
- Standard IV B Student Evaluation Outcomes Assessment August 1, 2009
 - Implement outcomes assessment beginning with academic year 8/1/09 7/31/10
 - Core Indicators = Graduate Satisfaction, Employer Satisfaction, retention, placement and program assessment examination (CFA or CSA exam)
 - Program initial annual reporting of outcomes

NEW 2009 REQUIREMENTS FOR NEWLY APPOINTED PROGRAM DIRECTORS

At the Fall 2008 Board of Director's meeting, the board approved a new mandatory professional development requirement for newly appointed program directors.

Effective <u>January 1, 2009</u>, all newly appointed program directors are required to attend an ARC-ST Accreditation Fundamentals for Educators (AFE) Workshop within **one** (1) year of appointment.

The AFE Workshop is designed to give program directors basic information on the accreditation process, including information on:

- Accreditation Definitions
- Types of Accrediting Bodies
- Institutional versus Programmatic Accreditation
- Accreditation Actions
- Terminology Associated with Accreditation
- The Accreditation Process
- Initial versus Continuing Accreditation
- Assessment Planning
- Standards Interpretive Guide

While this workshop is open to all Surgical Technology Program Directors and educators, newly appointed program directors will be required to submit proof of attending an AFE to the ARC-ST in support of their appointment.

The workshops will be offered three times per year:

- Friday before the AST Instructors' Forum (February)
- during the AST Instructor's Workshop (May)
- in Denver, CO at ARC-ST headquarters on July 18, 2009 or August 1, 2009.

The cost of the workshop is \$50 plus travel and accommodations.

ARC-ST 2009 Schedule of Fees Surgical Technology & Surgical Assisting Programs

Packet \$75

The ARC-ST Accreditation Packet (otherwise known as the Self Study packet) is should be ordered when a program is pursuing application for initial accreditation. Materials in this packet include miscellaneous accreditation process and procedure documentation as well as materials required for submission of the self study application.

Initial Application Fee

\$1200

This fee is due and must be submitted with the submission of the initial self-study application.

Initial On-Site Evaluation Fee \$2500

The initial on-site evaluation fee covers miscellaneous travel expenses incurred by the ARC-ST during the initial on-site evaluation. This fee is due and must be submitted with the submission of the initial self-study application.

Consultative Site Visit Fee

\$4000

(Effective January 1, 2009)

The consultative site visit fee covers miscellaneous travel expenses incurred by the ARC-ST during the consultative on-site evaluation. Please see the ARC-ST General Operating Procedures document to reference the circumstances when a consultative on-site evaluation is required. This fee is due and must be submitted at least one (1) month prior to the on-site evaluation.

Fees for the Random/Continuing on-site evaluations will continue to be included in the ARC-ST Annual Fee.

ARC-ST Annual Fee

for Maintenance of Accreditation* \$1500

This annual fee is due for all accredited surgical technology and surgical assisting programs. Programs will be invoiced between January and March of each year. (**Please note: CAAHEP invoices a \$450 dollar fee for the institution in May of each year).

Core Curriculum for Surgical Technology \$150

(available from AST's member services) According to Standard III.C, program must meet or exceed the curricular requirements defined in this document.

CAAHEP Accreditation Fee \$450

This annual fee is separate from the ARC-ST fee of \$1500 and will be billed by CAAHEP in the month of May.

This fee is for all programs pursuing approval of Distance Education, Satellite, and Consortium programs. Due upon submission of application.

AAD Initial Application Fee

This fee is for all programs pursuing the Accelerated Alternate Delivery Course Approval. Due upon submission of application.

Accelerated Alternate Delivery (AAD)

Option Annual Fee*

\$250

All surgical technology programs that have been approved to offer the AAD option will be invoiced an annual fee of \$250 in addition to the ARC-ST annual

Distance Education/Satellite/

Consortium Annual Fee*

\$500

All surgical technology and surgical assisting programs that have been approved to offer their program at multiple facilities through a distance education, satellite or consortium model will be invoice an annual fee of \$500, per additional facility, in addition to the ARC-ST annual fee.

Late Fee \$100

In addition, the ARC-ST will be strictly enforcing its late fee of \$100. This will apply to any materials received in the ARC-ST office after the assigned/ requested date. This fee will only be waived if the program notifies the ARC-ST prior to the due date of its inability to meet the assigned date and an extension is granted by the ARC-ST. Only one extension will be granted to each program.
